In 2014 with the aim of implementation of powder in Muslim countries the plant passed HAS 23000 certification (Halal Assurance System) from the LPPOM MUI organization.

In addition, in 2014, our company passed the 2nd stage of the certification audit of the management system of foodstuff safety in accordance with international requirements under the scheme of FSSS 22000.
