

## **Notification of the re-tender on selection of the investor to conclude the concession agreement on the concession project “Akulichskaya area (structure), Narovlyansky district, Gomel region”**

**Date, time and place of the tender:** March 1, 2017 at 15.00 at the address: Office 436, 10 Kollektornaya Street, Minsk.

**Application deadline:** November 30, 2016 at 15.00.

**Documents submission deadline:** January 16, 2017 at 15.00.

**Type of the tender:** open.

**Object of the competitive tender:** the right to sign the concession contract for the provision of services (work) providing the concessionaire with priority to conclude full concession contract with the Republic of Belarus if mineral deposits are detected on the concession project “Akulichskaya area (structure), Narovlyansky district, Gomel region”.

**General characteristics & location:** Akulichskaya area (structure) is a subsurface area in the projection of the earth’s surface of 83.7 hectares, situated in Narovlyansky district, Gomel region. In respect of oil-bearing lands, the plot is located within the southern district of the Pripyat oil and gas-bearing region with the density of the initial aggregate forecast hydrocarbon resources of 30 000-50 000 tons/km<sup>2</sup>. Within Akulichskaya area, 12 seismic lines were worked out with total length of 76 linear km. The density of the network of informative seismic profiles is 4.7 linear km/km<sup>2</sup>. Akulichskaya structure refers to the probable category III degree of safety. Intersalt sediments surface area is about 2.4 x 0.4 km, a promising area is 0.837 km<sup>2</sup>. According to D1 category, the geological oil resources of Akulichskaya structure are estimated at 485.6 thousand tons. Infrastructure & communication routes proximity: Slovechno railway station is 20 km to the west, Gazhin village is 10 km to the north-west, the highway Ovuch-Mozir is 18 km to the west, the highway Khoiniki-Narovlyany is 9 km to the east.

**Provision period:** 60 months as from the day of concluding the contract of concession.

**Registration deposit amount:** 410 USD (in Belarusian rubles at the exchange rate of the National Bank of the Republic of Belarus on the date of payment).

**First installment:** 4 185 USD (in Belarusian rubles at the exchange rate of the National Bank of the Republic of Belarus on the date of payment).
